

# **AUDIO AND VISUAL RECORDING AT FLEADH CHEOIL CHORCAÍ**

- A competitor's performance in competition may be recorded only with the prior permission of Comhaltas Ceoltoiri Eireann.
- Permission to record will be given at the discretion of Comhaltas Ceoltoiri Eireann on receipt of a completed application form along with the written consent of the competitor in question.
- A separate application should be submitted for each competitor or competing group (Duets, Trios, etc) which the applicant wishes to record.
- In the case of group competitions (Duet, Trios, etc) the written consent of one member of the group will be sufficient.
- The written permission of C.C.É. for a recording must be presented to the Call Stewards of the relevant competition before recording commences. If you are not in possession of a Video Permit you may not record a competition.
- Permission to record a competition applies only to the competitor's performance and not to any oral adjudication which may follow.
- The recording of a competitor must not interfere in any way with the smooth running of the competition.
- Permission for Recording Groups and Ceili Bands – Signed permission from Branch Secretary and/or Music Teacher is needed – **Forms available at Fleadh Office.**

The above guidelines regarding audio and video recording will be strictly upheld at Fleadh Cheoil Chorcaí 2017
